Greater Rochester International Airport Completes \$4 Million Energy Improvement Project

NYSERDA Provides More Than \$900,000 to Improve Power Reliability to the Airport

The New York State Energy and Research Development Authority (NYSERDA), the Greater Rochester International Airport (GRIA) and Siemens Building Technologies, Inc. have partnered on a \$4.3 million energy efficiency project that includes a state-of-the-art combined heat and power system (CHP), lighting and controls.

Combined heat and power systems enable commercial and industrial energy users to generate their own electricity while using waste heat from the electric generation equipment for productive purposes, such as space heating, cooling and domestic hot water. To date, NYSERDA has committed more than \$900,000 to various energy-related projects at GRIA.

NYAMA Knocks on Doors in Albany

Association Members Gather for Annual Advocacy Day

"In the midst of trying times, aviation remains the premiere form of transportation in the world today," said Stephen D. Williams, president of the New York Aviation Management Association (NYAMA), during the organization's opening session for the 2003 Annual Advocacy Day.

"Our challenge — and our focus today — is to educate state lawmakers about the importance of continued support from the state for the aviation community," continued Williams. "The extended downturn in the economy, increasing demand for improved security and the conflict in Iraq have all taken a toll on the industry. It's time for New York State to come to the plate and look at new ways to help the industry."

Airport managers from across the state — representing small and large, commercial and general aviation airports — and aviation industry consultants gathered in Albany on March 4th to advocate for the aviation industry in New York State.

The Association's Annual Advocacy provides opportunity to discuss with state legislators the importance of aviation to the state economy, and the need for renewed support from the state.

In the opening session, Association lobbyist Steve Acquario briefed attendees on the Association's legislative priorities for 2003, and the primary objectives for the day's activities.

"Chief among our objectives for the day is to educate state legislators about the importance of aviation to the state economy," said Acquario. "When you sit down and look at the numbers, it's astounding to see the incredible impact our industry has on local communities. The state's 18 commercial service airports and over 100 general aviation airports are attributed for over \$36 billion in economic activity in New York State. Over 300,000 New York State residents owe their jobs directly or indirectly to airports, accounting for an estimated \$12 billion in salaries and wages annually." *Continued on page 4*

President Bush Signs Spending Bill

President Bush on February 20 signed the fiscal year 2003 omnibus appropriations bill into law. The measure provides funding to DOT, FAA, the Transportation Security Administration (TSA) and a number of other federal agencies through the remainder of the fiscal year, which ends September 30.

The federal government has operated on a series of continuing resolutions since the new fiscal year began.

The following is a comprehensive list of airport-related items in the bill:

- Full funding of the Airport Improvement Program (AIP) at \$3.4 billion. Of that amount, \$20 million is made available for the Small Community Air Service Development Program and \$63.6 million is provided for program administration. Further, the bill directs FAA to provide specific dollar amounts from AIP for a number of designated “high priority” airport projects. - \$265 million within the TSA budget in new funds for terminal modifications necessary to accommodate explosives detection system (EDS) equipment.
- A new program within the TSA’s budget based on FAA’s Letter of Intent (LOI) process authorized at \$500 million per year for five years to help pay for EDS installation. However, an authorization does not necessarily guarantee funding. The measure includes report language on this provision that seeks to ensure adequate resources are available for smaller airports.
- A provision requiring TSA to pay for its use of space at airports other than at screening checkpoints.
- \$250 million to reimburse state and local entities for providing law enforcement at screening checkpoints.
- Provisions allowing for the continued use of state and local law enforcement officers on a voluntary and reimbursable basis at screening checkpoints and a modification of the “fixed post” requirement.
- A provision allowing airports to pay for FAA staff and consultants to help with environmental review work for key capacity projects.
- Full funding of \$78 million for FAA’s Contract Tower Program and \$6 million for the Contract tower Cost-Sharing Program.
- A provision making FAA Contract Tower construction and equipment AIP-eligible.
- \$113 million for the Essential Air Service Program.
- \$148 million for FAA Research, Engineering and Development.

The bill includes an across-the-board spending cut of less than 1 percent that will affect funding totals sited above. It also maintains the 45,000 cap on the number of TSA employees.

The bill also directs the FAA to provide specific dollar amounts from AIP for a number of designated “high priority” projects at specific airports. A list of those projects can be viewed at: www.airportnet.org/depts/federal/budget/AIPPriorityProjects.pdf.

“What I find particularly interesting,” continued Acquario, “is that a relatively small public investment leverages significant economic return for local communities and the State. For this reason alone, state lawmakers should see how critical — and beneficial — it is to maintain and increase the state’s financial support for aviation.”

The Association wrapped up the day’s activities with a Legislative reception in the evening.

“We had a lot of competition from other interest groups this evening,” said Acquario.

“The fact that we drew a sizeable crowd for our Legislative Reception, including several committee chairs from both houses, is a testimony to the importance of aviation in New York State.”

“There is no question that this event holds critical weight in the Association’s legislative efforts,” said Williams. “It’s so important that we have representation from airports across the state. Activities like this remind us how much strength we have in a unified, statewide voice.”

2003 Legislative Priorities

Support dedication of the \$1 M New York Statewide Opportunities for Airport Revitalization Program "NYSOARs."

These funds can be used for air service studies, market analysis, preparation of applications of public/private partnerships and the pledge of community and/or industry funding, to airports and communities where improved commercial air service is essential for the economic development of the community, and existing commercial services are characterized by unreasonably high air fares and/or insufficient service for the application to and the participation in the federal low fare demonstration program established pursuant to federal law. NYAMA recommends funds be used in part to:

- **Provide the non-federal share of the Federal Small Community Air Service Development Pilot Program for eligible NY airports.** The purpose of the Small Community Air Service Program is to recruit and retain air service in distressed areas of our state.
- **Provide for the continuation of the Statewide Aviation Training Program [SATP],** originally funded through the New York Legislature's Airport Improvement and Revitalization Program (AIR 99), and authorized by the New York State Department of Transportation. This important training program addresses the training and technical assistance needs of all airports located across the state.

Support Additional State Funding for Airport Improvement and Revitalization Grant and Loan Program (AIR 99), established in Section 14-1 of the Transportation Law and Section 88-d of the State Finance Law. All available funding for AIR 99 has been allocated. Additional monies are needed to upgrade airports, improve safety, attract additional air service and further promote economic development and transportation initiatives in airports and the communities they serve.

Support the continuation of the state's 5% matching share of federal AIP funds. Current funding proposed in 2003/04 Executive Budget is \$8M.

FAA Forecasts Modest Growth Through 2014

US air traffic is not expected to return to pre-9/11 levels until 2006, according to FAA's annual aviation forecast.

Even so, FAA forecasters remain optimistic, saying that US Major carriers can expect "positive growth in 2003," with international markets growing faster than domestic markets over the next 12 years. Director of Aviation Policy and Plans, John Rodgers said he is hopeful for "modest recovery in 2003" followed by stronger performances in 2004 and 2005.

Domestic capacity for US carriers is forecast to decline some 1% this year, mainly owing to extensive route restructuring primarily by United Airlines and US Airways. Domestic capacity is projected to increase 3.3% in 2004, 3.5% in 2005 and 3% in 2006, when the industry climbs back to pre-9/11 levels.

Much of the growth will occur in Latin America and the Asia/Pacific region with annual increases of 5.1% and 4.7% respectively, FAA said. The forecast said Regional airlines will continue to grow at a faster rate than Majors through transfer of mainline routes as well as expansion into new markets.

Previously, FAA predicted that a billion passengers would be flying yearly by 2014, but officials now are expecting between 850,000 and 900,000 passengers by then.

A key to recovery centers on the ability of airlines to reduce their costs to become more competitive with low-cost carriers. Rodgers said, "We've got a good product and there is a way to market that product for traffic." Additionally, he said risks to the accuracy of the forecast include international tensions, the continued decline in the number of business travelers and the ability of airlines to continue to cut operating costs.

In spite of the industry downturn over the past two years, Rodgers said many hub airports still are experiencing congestion during peak hours. But the overall slowdown affords an opportunity to plan for increased demand that is expected to return over the next several years. "In a dozen years we expect a significant increase in airline activity and we have to prepare for it," he said.

House Begins FAA Re-authorization Debate

Rep. John Mica (R-Fla.), Chairman of the House Aviation Subcommittee, recently proclaimed his intention to preserve the gains achieved in AIR-21 as Congress begins work on FAA Re-authorization. The current FAA authorization bill expires in September, and Mica said he wants to mark up the new bill this Spring.

During a February 12 Re-authorization hearing, lawmakers discussed the uncertain future of the aviation industry and raised concerns about service to small communities. Several members voiced their opposition to using a growing portion of Airport Improvement Program (AIP) funds for security purposes.

In his testimony, DOT inspector General Ken Mead described the \$3 billion to \$5 billion shortfall in funding to install explosives detection system (EDS) machines behind the ticket counters at airports.

However, Rep. Shelley Berkley (D-Nev.) commented, "We should make sure security does not impact safety and capacity." Rep. James Oberstar (D-Minn.) said there is a need to "recapture" AIP dollars for capacity.

Gerald Dillingham, Director of Civil Aviation issues at the General Accounting Office, pointed to ACI-NA's estimate that the average annual capital development cost at airports will be approximately \$15 billion between 2002 and 2006. He noted that if airports continue to receive about \$12 billion a year for that purpose, they are already facing a \$3 billion shortfall before funds are diverted for security purposes.

Dillingham echoed Mead's recommendation that air traffic system capacity be expanded in order to meet future demand. He cited a recent GAO report that stated airports spent approximately 10 years building recently completed runways. It will take approximately 14 years to build runways that have not yet been completed, the report found.

"Ensuring the efficient operation of the nation's airspace system is an important Re-authorization issue that is vital to improving mobility and supporting economic growth," Dillingham said. "Despite the overall decline in air traffic since September 11, demand is gradually increasing, and at some airports, especially those in the Midwest, recovery is progressing more rapidly."

Mica said that improving service to small communities will be another area for attention in the next FAA Re-authorization bill. In background information prepared for the hearing, the subcommittee described a few possible remedies to improve this service, including potential changes to the Essential Air Service Program and allowing foreign airlines to provide service to small communities.

“New York State leads the way in terms of combined heat and power system installations. Our programs will ensure waste heat from this style of power generation is used to maximize efficiency and environmental benefits,” said NYSERDA Acting President Peter R. Smith. “This technology will provide users greater control over their energy costs while protecting them from power disruptions and blackouts that could bring negative impacts on the airports operations.”

“This new heating and power system gives the airport the cost efficiency and the operational independence so important to meet the current times,” said Monroe County Executive Jack Doyle. “We expect to save approximately 48 percent or more than \$480,000 in annual energy costs at the airport. NYSERDA has not only helped our airport greatly, but has assisted in more than 180 other projects with industry and businesses here in Monroe County. I applaud the Governor for his vision and support in this critically important arena of energy efficiency.”

To highlight the project, GRIA will open a website, www.rocenergysavings.com, and kiosk to provide an overview of the project for business and institutions interested in CHP. The site will present information about the type of CHP system installed, diagrams of the system and details of the sites energy and environmental gains from the system operation. The website will also include a video developed by four local high school students from Churchville Chili Central Schools who worked on this project under an internship with Siemens Building Technologies, Inc. The system is expected to yield a reduction of more than 6 million kilowatt hours per year or enough electricity to power more than 1000 homes. GRIA is expected to save approximately \$334,000 in annual energy costs.

The combined heat and power system for the airport provides multiple benefits for the airport facility, airport travelers, and county taxpayers. These benefits are realized through energy cost savings, increased power quality and reliability, environmental improvements and increased stability relating to future energy costs at the airport.

The CHP system consists of two medium-sized 750-kilowatt engine driven co-generation units that produce electricity and hot water. The hot water is linked to the existing airport heating system and central cooling system. Hot water heat recovered from the Cogeneration units is used to heat the airport in Winter, but through a special mechanism known as an absorption chiller, it also provides the conditioning requirements in the Summer. The CHP plant simultaneously produces most of the airport's electricity as well as its hot water, building heat and air conditioning.

The 56 projects NYSERDA is supporting represent a total investment of \$96 million in combined heat and power when co-funding for the projects is factored in. The CHP program and the projects supported will address power generation, availability, reliability, and power quality needs of New York State while emphasizing energy efficiency and environmental quality. The projects are expected to result in direct energy, environmental, and economic benefits such as peak electric demand reduction, higher fuel-use efficiency, emissions reduction, lower energy costs, job creation, and product sales.
