Design/Construct Category

McFarland Johnson submitted a project involving the development and implementation of a radiant heating system for an apron at the Greater Binghamton Airport. The heating system, which is integrated into the pavement, will melt ice and snow, reducing build-up and easing snow removal.

Non-Design Category

McFarland Johnson submitted a non-design project related to increasing sustainability efforts for the Buffalo Niagara International Airport and integrating them into its sustainability master plan. The planning process was also linked to the National Environmental Policy Act (NEPA).

NYAMA Wraps Up Final Peer Review Workshop of the Year

NYAMA hosted its last Peer Review workshop for 2012 on Wednesday, September 12th at Westchester County Airport in White Plains, New York. The Wildlife Management Plan Peer Review Session covered a wide variety of topics related to effective and best practices for wildlife management that coincide with Federal Aviation Administration and United States Department of Agriculture guidelines.

The Wildlife Peer Review drew in over 30 attendees—many of them wildlife specialists and managers of nearby airports. "Westchester County Airport was thrilled to host this Peer Review", said Stephen Ferguson, Assistant Airport Manager at Westchester County Airport, who moderated the program. "We had a fantastic turnout that provided us with tremendous insight from leading experts about wildlife management strategies here in White Plains, and helped us to understand other unique wildlife management problems in New York State and throughout the country". Ferguson noted that the workshop's popularity may lead to another one next year at about the same time, during rutting and migration season. Joel Russell, Manager of Albany International Airport, who helped organize September's event, was equally enthusiastic about turnout and participation: "We had a terrific overview of the most up-to-date planning and implementation methods related to managing local wildlife at airports. We were pleased to welcome experts from USDA and other airports who have had extensive experience in this area to share their own experiences."

NYAMA would like to extend its gratitude to guest speakers at this last Peer Review, including Ari Elinsky, Manager of Construction, Wildlife, and Security at New Jersey's Teterboro Airport, who spoke about that airport's wildlife management program; Matthew Palumbo, USDA Wildlife Services, who spoke about USDA presence at Westchester County Airport and the successful relationship with that airport's operator; Susan Vilord of Clough Harbour & Associates, who spoke about wildlife management programs and their importance for consideration in airport master planning, and John Starace, Operations Manager at Westchester County Airport, who spoke about that airport's wildlife management program.

Legislative Update

NYS DOT Two Year Transportation Capital Plan Proposal

Recently, the New York State Department of Transportation submitted a proposed Two Year Capital Plan to the New York Works Task Force. The Task Force is a 13-member panel appointed by the Governor and legislative leaders that is charged with developing a statewide infrastructure plan to effectively and strategically allocate New York's capital investment funding and create jobs.

The Plan is not funded (a funding plan is expected to be part of the Governor's Executive Budget, to be released to the Legislature in late-January 2013), but instead represents the DOT's "reengineered" capital program focused on "asset management and infrastructure preservation strategies" that link "transportation with economic development". The level of funding aviation systems need depends on the state's ability to finance the Plan's Strategic I and Strategic II Investment Levels.

While the Plan contains few details and has no accompanying project lists as yet, NYAMA should be encouraged by the Plan's treatment of several budget areas of concern to us for which we have been aggressively advocating:

Airport Improvement Program (AIP) Match

Under the Strategic I investment alternative, New York State would continue to provide matching funds for fifty-percent of the non-federal share of Federal Aviation Administration (FAA) Airport Improvement Program (AIP) Grants to New York airports, leveraging important Federal aid. NYAMA argued for this increase based on the 2012 changes to the Federal Aviation Authorization legislation that increased the non-federal share from five percent to ten percent of the total project cost for most airports. Thus, the proposed two-year capital program doubles the match available for this program as requested by NYAMA.

Critical Transfer Language Endorsed by DOT

In 2007, NYAMA succeeded in adding language to the State Capital Projects Budget that authorized the transfer of the unused portion of AIP Match funds to the AIR '99 program to fund revenue-producing infrastructure improvements, economic development, job creation, and safety and security projects.

This language, however, has not been included in all budgets since 2007. The Plan once again proposes that unused AIP matching funds be redirected to support aviation infrastructure investments. This is another critical endorsement of a NYAMA initiative.

Strategic II Investment Funding

The AIR-99 Program provided \$15 million per year for vital airport infrastructure projects. This important program expired in Fiscal Year 2009-2010, and was the last year state funding was dedicated to airports—other than through the AIP Match program.

NYAMA has been seeking state approval of a dedicated fund or revenue source that would re-fund AIR-99. We have been heard—the Strategic II Investment Level of the Plan proposes \$14 million of funding for airports over the next two years. This funding would be directed to commercial and general aviation airports that sustain and create jobs, and generate income for local economies.

Continued NYAMA Advocacy

To insure that all of these DOT proposed enhancements to state aviation funding are included as part of the Executive Budget Proposal and are ultimately enacted, NYAMA will continue to be the Voice of Aviation in New York and work with the Governor, state legislators, and policymakers to promote investment in airports and the state's aviation industry.

New York Airport Improvement Projects Are on the Rise

n the current economic environment. New York's aviation industry has made considerable progress in moving forward with improvement projects at airports across the state. Numerous projects are in various phases of planning and construction from the Southern Tier to the North Country to the Hudson Valley. Over the last two months alone, airport improvement projects have been announced, started or completed due in large part to a new round of funding through the Federal Aviation Administration and U.S. Department of Transportation. New York State has provided some funding as well. New York airports to benefit from this recent flow of investment capital include: Plattsburgh International Airport, Greater Binghamton and Tri-Cities Airports in Broome County, Elmira Corning Regional Airport, Stewart International Airport, Buffalo Niagara International Airport, and Griffiss International Airport in Oneida County.

Much of the funding has or will go towards infrastructure projects at the airports. Almost all of them have used at least small portions of their funding for runway improvement and expansion. This is good news for these airports' regional economies, which are starting to see a boost in construction, engineering, and management jobs as a result. Many of the much-needed jobs are temporary, but the end products they provide for Upstate New York will quickly increase passenger traffic and airport operations once completed, which can only help New York, not hurt it.

New York Airport Improvement Projects Currently Planned, Underway, or Completed:

- Plattsburgh International Airport: The FAA has awarded \$6.55 million for the airport to upgrade its runways and its main terminal. Nearly half of that grant will be used to fund a project related to Plattsburgh International's water management.
- Greater Binghamton Airport: A \$1.2 million grant from the FAA has been awarded to improve drainage and paving of some of the airports critical operational service areas.
- Tri-Cities Airport: Located in Endicott, NY, Tri-Cities will use \$1.4 million from the FAA to repave its heavily used primary apron.
- > Elmira Corning Regional Airport: The U.S. Department of Transportation provided nearly \$10 million for the airport's recently completed runway expansion, which will allow it to accommodate bigger commercial airliners. The airport is expecting sizable increases of passenger traffic as a result.
- > Stewart International Airport: \$1.95 million in federal funding will contribute to runway improvements.
- **Buffalo Niagara International Airport:** The airport is ready to begin an expansion of one of its long-term parking areas, using close to \$7 million in funds from the state.
- Griffiss International Airport: Griffiss, a former U.S. Air Force base, will receive \$270,000 through the Military Airport Program, a federal initiative to turn military airports into facilities for public use. The MAP funding will be used to improve the airport's hangars. The U.S. Department of Transportation will provide an additional \$475,200 for various improvement projects as well.



The few airports where NextGen has been adopted mostly deal with the satellite-based technology on a limited or trial basis. Yet NextGen, which is more accurate and reliable than conventional radar guidance systems, is gaining ground with public and government policymakers, and New York State may be a major testing ground for it.

As this summer's *Air Currents* went to print, New York's aviation industry took a big leap forward when the FAA announced that a new air traffic control facility, which will use NextGen and function for the New York City area and parts of New Jersey and Pennsylvania, will be located in New York State. Despite the mystery of its actual location (the FAA has not decided where in New York yet), such a facility is an automatic win for New York aviation and the state's economy.

Operating in such a busy area, the new air traffic control center will undoubtedly boost NextGen's profile and, if successful in the short-term, will serve as an example for other aiports and regional hubs to switch over to it in the long-term, saving fuel for every flight and putting more travelers in the air at once.

The new NextGen center itself will also provide jobs for its region. Increased air traffic will mean busier airports and jobs to serve them. Whether the facility comes to Stewart International Airport or Long Island MacArthur Airport—the two have recently made headlines as they compete for the opportunity to house the new facility—or it comes closer to New York City, it will unquestionably change New York State for the better.
